  - 3.3 Stipend based on the number of service hours rendered but not more than 60 hrs/month for MS and 80hrs/month for PhD at the fixed rate of Php100 per hour ( as indicated in the implementing Rules and Regulations of the UP GMAP)
- 4. The FM shall attest and certify as to the number of hours rendered by the GA
- 5. At the option of UPLB, this agreement may be renewed until the completion of the degree / subject of the GA, subject to performance evaluation by the Faculty Mentor and the UPLB GMAP Committee
- 6. On reasonable grounds, and with due consent of the FM when the GA is unable to continue his studies, he may be allowed to give up the award prior to completion of the studies. In case the FM does not issue his consent, and the GA gives up the award, the GA shall pay back the University for the Stipend received and the school fees waived by the University for that semester as defined under sections 3.1; 3.2 and 3.3.
- 7. The GA shall perform all other duties recited in the above issuances governing the GMAP.
- 8. The GA and the UPLB has no employer-employee relationship.
